## Rift Widens Between Paris and Ankara

Turkish President Recep Tayyip Erdogan seized another opportunity to establish himself as the leader of the Muslim world by lending his support to a campaign calling for the boycott of French products on Monday (26 October). The campaign, which had been surging across the Arab world on social media last weekend, was triggered by French President Emmanuel Macron's characterisation of Islam as a religion "in crisis" after history teacher Samuel Paty, who showed his students satirical images of Prophet Mohammed by cartoonist Charlie Hebdo, was beheaded. Early responses suggest countries are dividing along contentious egional lines, with Turkey and its allies on one side and Saudi Arabia and its suppo the other. Qatar and Iran have joined Turkish criticism of France while the United Arab Emirates has remained silent.

## Qatar 'Regrets' Invasive Searches of Women Defending its decision, the Qatari government expressed "regret" on Wednesday (28

October) over the invasive medical exams performed on more than a dozen women who were pulled from a Qatar Airways Sydney-bound flight in Doha. The invasive searches were held to check if these women had recently given birth after a newborn baby was found abandoned in a bathroom at Hamad International Airport. This episode, which sparked shock and outrage in Australia and other countries, has highlighted the treatment of women in Qatar and also raised questions about whether foreign women travelling through the airport could legally be subjected to invasive and non-consensual procedures.
