
Hurdles in KSA's Economic Transformation

As Saudi Arabia steamrolls ahead with its ambitious Vision 2030 economic reforms to create jobs and diversify away from oil, many hurdles continue to remain. While unemployment has fallen steadily from a pandemic-era high of 15.4%, jobs remain scarce for educated citizens, while foreigners continue to dominate the workforces of many sectors. Would-be investors are concerned about the business climate in the country, especially after the detention of dozens of businessmen for alleged corruption in 2017. Tourism is a vital element of Vision 2030 but the kingdom faces stiff competition from other more established places such as Turkey and Malaysia.

A recent drone attack on Iraqi Prime Minister Mustafa Al-Kadhimi's residence highlighted

the threat posed by Iran-allied paramilitary groups in the country. The assassination attempt, which US officials say was likely perpetrated by an unspecified Iran-backed Iraqi militia, has since sparked a mediation process with several militia groups agreeing to condemn the strike. A top Iranian general was also sent to Baghdad to de-escalate tensions. Observers say that Iran-allied militias hold considerable influence over Iraqi security and institutions and the defeat of their political parties in last month's parliamentary election have triggered their concerns over their continued role in the country.

UAE Foreign Minister Sheikh Abdallah bin Zayed met Syrian President Bashar al-Assad in

Damascus to discuss the development of bilateral co-operation between the two countries. Sheikh Abdullah is the most senior Emirati official to visit Syria since the start of its civil war in 2011, as well as the first high-profile Arab official to meet with Mr Assad since 2019. The

meeting is the strongest signal yet of a normalisation of regional ties with Mr Assad's government, prompting criticism from Western states that remain concerned with human rights abuses by his regime.

Iran Seeks Relief from Sanctions

As the resumption of international negotiations over the revival of the Iran nuclear deal looms overhead, Tehran has called for the US to accept responsibility for abandoning the deal and pledge not to

leave the accord once again. The next round of the nuclear talks, which have been stalled since June, is set to be held in Vienna on 29 November. A senior Iranian source said that Iran is seeking relief

from all sanctions imposed upon it since the Trump administration's exit from the deal.

Major Energy Conference to Discuss COP26 Decisions

At least 32 government ministers are slated to attend the Abu Dhabi International Petroleum Exhibition and Conference to be held from 15 to 18 November 2021. The event, which is the largest and most influential global energy forum, is held under the patronage of President His Highness Sheikh Khalifa bin Zayed Al Nahyan and hosted by the Abu Dhabi National Oil Company. It also presents the global energy industry with its first opportunity to discuss the impact of key decisions of the 26th UN Climate Change Conference of the Parties
