## Israeli Firm's Spyware Linked to Cyberattacks Researchers from internet security firm Eset have found new evidence that suggests the

spyware made by Candiru, an Israeli company that was recently blacklisted in the US, has been used to target critics of autocratic regimes, including some high-profile websites in the Middle East and the United Kingdom. Candiru and NSO Group, another Israeli surveillance company, were both added to a US blacklist after the Biden administration took the rare step of accusing the firms of acting against America's national security interests. NSO Group's signature spyware, Pegasus, infects mobile phones whereas Candiru's malware is believed to infect computers.

# UAE National Security Advisor to Visit Iran

The UAE's National Security Advisor, Sheikh Tahnoon bin Zayed Al Nahyan, is set to travel to Iran next week on a rare visit, according to an informed source in Abu Dhabi. This comes after Anwar Gargash, former Emirati minister of state for foreign affairs stated that the UAE "has taken steps to de-escalate tensions (with Iran) as we have no interest in a confrontation." Sheikh Tahnoon was reported to have visited Tehran in October 2019 for an Emirati-Iranian

## security dialogue that was geared to de-escalate tensions in the aftermath of ex-US president Donald Trump's exit from the nuclear deal and re-imposition of all sanctions under a "maximum pressure" campaign.

Singapore to start VTLs with Qatar, UAE, KSA In a further expansion of the Vaccinated Travel Lane (VTL) scheme, travellers from Qatar, Saudi Arabia and the UAE will be able to enter Singapore from 6 December 2021. Singapore is also in talks with India to resume scheduled commercial services between the two countries by 29

November 2021. Travellers can travel without quarantine to and from India, Qatar, Saudi Arabia and the UAE, which earlier opened their borders for vaccinated travellers from Singapore.
